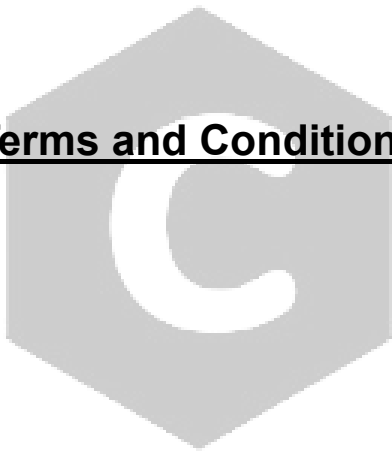


Terms and Conditions
